

**RELEASE, ASSUMPTION OF RISK, WAIVER OF LIABILITY
AND HOLD HARMLESS AGREEMENT FOR**

GROUPS, COUNSELORS, AND OTHER ADULTS

I, the undersigned, or a group under my control, will be engaging in activities (collectively, the “**Activities**”) on various parcels of real property owned or controlled by Green Valley Bible Camp (“**Green Valley**”) (collectively, the “**Property**”), and having read and understood this Release, Assumption of Risk, Waiver of Liability and Hold Harmless Agreement (“**Release**”), I voluntarily agree to the following:

A. I hereby RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE Green Valley, and/or any of it’s affiliates, including officers, directors, managers, members, board members, agents and assigns (collectively, the “**Releasees**”) for any liability, claim, and/or cause of action arising out of or related to any loss, damage, or injury, including death, that may be sustained by me, or to any property belonging to me, or to the individuals who are part of the group under my control, that occurs as a result of my participation in the Activities.

B. I agree to INDEMNIFY AND HOLD HARMLESS the Releasees, from any loss, liability, damage or costs, including court costs and attorneys’ fees that the Releasees may incur due to my participation, or my group’s participation in the Activities on the Property. The covenants in this paragraph apply whether the loss, damage or injury is caused by my negligence, the negligence of any of the Releasees or the negligence of any third party.

C. I freely choose to engage in the Activities on the Property and to participate in the Activities, and I freely accept all of the risks associated with the Activities on the Property.

D. It is my express intent that this Agreement shall bind the members of my family and my spouse if alive, and my successors, heirs, assigns and personal representative if I am deceased, and shall be deemed a RELEASE, WAIVER, and DISCHARGE and a COVENANT NOT TO SUE the Releasees.

E. I understand that by participating in the Activities and working on the Property I will ASSUME THE RISK of injury and damage from risks and dangers that are inherent in any of the Activities on the Property.

F. If I deviate from any aspect of the Activities, such deviation is purely voluntary, and I agree that none of the Releasees shall be liable for any injuries resulting or arising out of such deviation.

G. I further agree that this Release shall be construed in accordance with the laws of the State of Arkansas, and I agree that any issue relating to this Agreement shall be resolved in the jurisdiction in which the Property is located.

H. I further specifically agree that the Activities are occurring during a time period in which the risk of the COVID-19 infection is elevated. By signing this Release, I specifically agree and certify that I and the group under my control have taken all necessary and required pre-Activity precautions and followed all applicable guidelines with respect to testing and screening for COVID-19 and I both I and the group under my control will abide by all applicable guidelines with respect to social distancing, wearing masks and other required COVID-19 precautions during the Activities. I further RELEASE, WAIVE, DISCHARGE and COVENANT NOT TO SUE Green Valley for any damages or injury related in any way to COVID-19.

IN SIGNING THIS RELEASE, I ACKNOWLEDGE AND REPRESENT that I have read the foregoing Release, understand it, and sign it voluntarily. I further certify that I am legally competent to sign this Release, that I understand that the terms of this Release are legally binding, and that I am signing this Release only after having carefully read and understood the same. I fully understand that the Releasees would not allow me to engage in any of said Activities on the Property without receipt of this signed Release.
